The September meeting will be a Soup Cook-off led by Suzanne Timko. You may want to bring your own spoon!







Flagler Beach Yacht Club Officer Duties

Commodore:

- CEO of Club
- Chairperson of Board, General Membership and Special Meetings
- Signs all club legal documents
- Manage Club to member communication
- Manage Club Liability Insurance
- Play an active role in mentoring/assisting Club Officers in the accomplishment of their duties
- As an ambassador of the Club, attend as many Club functions as possible
- Voting member of the Board of Directors only in the event of a tie vote
- Other duties as needed

Vice Commodore:

- Perform Commodore duties as needed
- Participate in Board, General Membership and Special Meetings
- Chair Social Committee, responsible for all off water events, membership meetings and socials
- Attend as many Club functions as possible
- Ex-officio member of all Club Committees (Example, Maritime Committee Meetings)
- Coordinate Social event dates with Maritime Committee
- Manage Club storage activities
- Purchase and maintain Club meeting supplies
- Manage Club General Membership meeting place
- As an ambassador of the Club, attend as many Club functions as possible
- Voting member of the Board of Directors
- Other duties as assigned
